

# **Treasurer's Report**

Interim - June 30, 2019

Your Beatitude, Your Eminences, Your Graces, Reverend Fathers, brothers and sisters,

Attached is the Treasurer's Report for the quarter ended June 30, 2019. The report includes the following:

- \* Statement of Operating Activity Unrestricted
- \* Statement of Operating Activity Restricted
- \* Comparative Balance Sheet for June 30, 2019 and June 30, 2018

June 30, 2019 represents 6/12ths of the OCA's fiscal year, so the target for operating revenues and is expenses is 50%.

#### Revenues

Revenue collection was at \$901K on an annual budget of \$1,809K (49.78%), substantially on target for the first six months of the year. Diocesan assessments have just exceeded 50%. On the other hand, the bulk of Stewards of the OCA (SOCA) activity occurs in the latter half of the fiscal year so this particular revenue stream fell below the 50% target.

#### **Expenses**

Expenses incurred through June were \$912.5K on an annual budget of \$1,809K (50.43%). Expenses were substantially in line with the budget overall; however, individual cost centers have seen some overage due largely to higher-than-anticipated health insurance premiums and the timing (earlier in the year) of planned travel.

#### **Net Income**

Unrestricted net income is a \$12K deficit through June. However, as noted in "Revenues" above, most SOCA activity occurs in the latter half of the year and we anticipate recovery of this deficit during the balance of the year. Finally, a number of expenses shown as unrestricted activity have corresponding restricted funds for which there will be a release from restriction at year-end (e.g., \$36K for Mission Planting grants).
